### FAQ: UBO DECLARATION

- Is the company listed in a stock exchange? Yes if the corporate owner (parent company) is publicly listed.
- Is the company owned by a company in a UAE Financial Free Zone Yes if the corporate owner (parent company) is incorporated in <u>ADGM or DIFC</u>.

### STEP 4 UBO DECLARATION

- Ownership Structure Diagram: Upload a chart that clearly shows the entire ownership structure of the company, extending all the way to the individual owners.
- Ownership Document: Upload the most recent document that lists the owners of the corporate parent company.
- After uploading the documents, click on the "Submit" button to complete the process.

#### Note:

If the company is owned by multiple companies or has a multi-layered ownership structure, the Compliance Team may request further documentation after reviewing the initial submission.



# STEP 5 UBO DECLARATION

- Locate and click on the "Edit" button to access the Corporate Shareholder Details section.
- Enter the required information about the corporate shareholders.
- After completing the details, click on the "Submit" button.



## STEP 6 UBO DECLARATION

- After you have entered and submitted the Corporate Shareholder Details, proceed to the next step.
- Click on the "+" sign beside the company name and click on "Add UBO" button to input details about the individual owners.
   Note:

If Company A is owned by Company B, and Company B is owned by Company C, then you should provide the details of the individual owners of Company C who hold 25% or more of the shares.



# STEP 7 UBO DECLARATION

- Make sure that every section of the form is filled out thoroughly.
- Check that all the details you enter on the form match exactly with the information on the passport you submitted.

### Note:

The passport should match the nationality and should be at least valid for 6 months.



### STEP 8 UBO DECLARATION

Read the Terms and Conditions, tick the box at the bottom and click on "Confirm".

Ensure that all parts of the form are marked as "Submitted" and that they are highlighted in green.
